

NOTICE OF EXPRESSION OF INTEREST FOR THE IDENTIFICATION OF STUDENTS AT THE UNIVERSITY OF PAVIA INTERESTED IN PARTICIPATING IN THE EXPERIMENTAL PROJECT "CO-HOUSING AND CARING BETWEEN GENERATIONS" - INTERGENERATIONAL EXCHANGE MEASURES TO SUPPORT THE INCLUSION OF THE ELDERLY POPULATION – RECTIFICATION

#### **Rectification Note:**

Considering the changes to the participation conditions of the project and the deadlines for applications, this document rectifies the "notice of expression of interest for the identification of students at the University of Pavia interested in participating in the experimental project 'Co-Housing and Caring Between Generations' - intergenerational exchange measures to support the inclusion of the elderly population," published on the university's official register on 20/09/2024, protocol no. 172462 of 19/09/2024.

#### 1. PREMISE

This notice aims to explore the interest of students enrolled at the University of Pavia (academic year 2024/2025) who wish to participate in the experimental project "Co-Housing and Caring Between Generations" – Intergenerational exchange measures to support the inclusion of the elderly population, as described in section 2 of this document.

Adhering to this notice does not create a commitment for either party to finalize the action for which interest has been expressed but aims to better define the area of interest to facilitate intergenerational meetings.

## 2. OBJECT OF THE NOTICE

The project includes the development of two actions:

a) CO-HABITATION: Intergenerational living and cohabitation between students and individuals over 65.

This action aims to promote an alliance between the student population and citizens over 65 in Pavia. It is not an assistance-type relationship, but an intergenerational pact aimed at fostering supportive relationships through a regular rental contract (cohabitation as a means of active inclusion).

The University of Pavia sees this intergenerational pact as an opportunity to support integration between the student population and those over 65, along with a strategy to address the increasing demand for affordable rental housing from students living away from home. The balance between supply and demand for housing has led to a significant increase in prices and insufficient availability of accommodations, which this project aims to address through innovative solutions such as "intergenerational cohabitation."

Alongside a "cohabitation pact," students will also provide essential yet fundamental services based on their skills and the needs of those over 65 (e.g., use of IT resources such as SPID; assistance in accessing healthcare; guidance to administrative offices; socialization and leisure activities, etc.). It aims to promote a new way of living that ensures better quality of life for both young and elderly individuals and combats loneliness through the sharing of relational resources.

The rental contract will be defined with the assistance of industry associations participating in the project, which will oversee the process, taking into account the actual space and services available to the guest. Accommodations may also be located in nearby municipalities. The University will contribute up to a maximum of 300 euros per month per student towards the rent. This rental contribution will be paid directly to the landlord.

# b) GENERATIONAL SUPPORT: Relationships and services provided by students to support individuals over 65.

This action aims to offer individuals over 65 supportive services primarily focused on creating healthy friendships and solidarity relationships, based on volunteer work provided by university students, not necessarily in cohabitation situations. These activities include forms of meeting, listening, and information organized at the university on topics of interest to over 65, such as:

- Film screenings (film club) at the university's cinema-auditorium
- Musical evenings featuring student musicians
- Scientific dissemination events led by PhD students
- Health promotion days for the elderly
- Visits to museum locations and university exhibitions
- Visits to green areas and the Botanical Garden
- Wellness and fitness programs (university sports and leisure facilities)
- Days dedicated to intergenerational sharing of life memories. Additionally, at the university, thanks to equipped rooms with reserved study areas, students can support and train individuals over 65 in:
- Using technological and IT tools (mobile devices, PCs, tablets)
- Language conversations with foreign students
- Reading texts.

The two actions (a) and (b) are not mutually exclusive. Interested students may express interest in one of the two actions or both.

Participating students will be awarded elective or additional university credits within their individual study plans based on the activities undertaken to support the elderly and/or Open Badges.

## 3. TARGET GROUPS OF THE INTERVENTION - PARTICIPATION REQUIREMENTS

Eligible individuals for benefit under point 2.a "CO-HABITATION: Intergenerational living and cohabitation between students and individuals over 65" are (all listed requirements must be met):

- Students regularly enrolled at the University of Pavia for the academic year 2024/2025, aged between 18 and 32, appropriately placed on the rankings for access to university student support measures, but not benefitting from accommodation<sup>1</sup>;
- Students living away from home, residing in a location different from where the rented property is located for their university studies;

## 4. HOW TO PARTICIPATE IN THE SELECTION

Students interested and meeting the requirements outlined in point 3 must submit their application by filling out the attached form and sending it to the address **over65@unipv.it** by **October 30, 2024,** along with all requested documentation.

It is requested to specify in the subject of the email the name of the project "CO-HOUSING AND CARING" and the action for which they are applying, for example:

"First and Last Name - CO-HOUSING AND CARING - application action [specify if 2a, 2b, or both]."

Applications that are entirely or partially incomplete in the required data and documentation or those whose eligibility cannot be verified will not be accepted.

## 5. IDENTIFICATION OF ELIGIBLE CANDIDATES AND DETERMINATION OF CONTRIBUTION MEASURES

The University of Pavia will conduct necessary checks and will arrange an interview with the interested student to assess motivations and eligibility based on the order of application submission.

Students will be accepted until the maximum number of available accommodations/actions is reached.

## 6. CONSEQUENCES IN CASE OF FALSE STATEMENTS

In the event of false declarations concerning self-certifications provided by students who are beneficiaries of the benefits mentioned in this notice, penalties as per articles 75 and 76 of D.P.R. 445/2000 may be applied, in addition to the revocation of the granted benefit. Disciplinary sanctions and reporting to judicial authorities may also be pursued if criminal implications are identified.

#### 7. EXCLUSIVE JURISDICTION

For any disputes arising from this notice or its application, the competent jurisdiction is that of Pavia.
